## **Motions, Director Nominations and Voting**

To vote each member will need to use a separate device, two members will not be able to vote using the same device. Non-members are welcome to the meeting, but to vote, submit a motion or nominate a board director <u>you must be a paid up member in 2020.</u> The best way to join or renew your membership is on our website. We can also post you a membership form.

Membership renewals must be completed before the meeting, please renew your membership no later than Tuesday 24<sup>th</sup> November to allow us time to process the renewal before the meeting.

The deadline for submitting a motion or nomination form is November 7<sup>th</sup>. Forms can be submitted by email or post. Motions and AOB at the will only be accepted if they are relevant to the meeting proceedings:

- Directors and Auditors report
- Election of Directors
- Appointment of Auditor
- Memorandum and Articles of Association (M&As) IDS board will be presenting members
  with a new constitution early next year for approval. We ask you to hold any motions related
  to the current constitution because it will be completely replaced early next year.
